Banns:

If one of you lives in another parish outside the Benefice, a Certificate of Banns is required from that church before the wedding can go ahead, to prove that there were no objections when called.

It is **your** responsibility to see that this is done and presented to the Priest taking your wedding service before the wedding day.

If unsure of your parish look on the web at www.yourchurchwedding.org

ID documents:

You will need to show the vicar your passports as proof of nationality. If you don't have a passport, there are other documents which are acceptable.

If either or both of you are divorced, you will need to bring your decree absolute .

You may also be asked to provide evidence of your connection to the church, such as utility bills which show you live or have lived in the parish, or your parents' marriage certificate if they were married there, for example.

Hymns & Music:

Two or three hymns need to be chosen in good time before the wedding day, in consultation with the Vicar and/or the Organist. (especially before sending to the printers for an Order of Service). For more advice look at www.yourchurchwedding.org

The organist who will play for your wedding can help you with music and hymn choices. Please check with the Vicar who this will be.

Video recording:

You need to let us know if you wish to record your wedding service as extra arrangements will need to be made; we can advise you on this. Recordings may only be made for private use and music may not be used for commercial use or financial gain.

To comply with GDPR rules, it is your responsibility to check with your wedding guests that they are happy to be in any recordings. You will also be charged an extra fee if you wish to record the music. *(See over for fees)*
